Vadhvan Port project gets go-ahead for sand mining from the sea for the purpose of reclamation

Exim News Service MUMBAI, March 2 ADHVAN Port Project Ltd (VPPL) is developing the



deep draft greenfield Vadhvan Port in Palghar District of Maharashtra. The port is to be developed on reclaimed land of 1,448 ha, which is to be created in the sea, involving filling of sand of about 200 million CuM. The sand will be dredged at a place in the sea which is 60 km from site and 50 km off the coast of Daman.

For the purpose of dredging, 10,277.1 ha (102.77 sq. km) area offshore has been reserved by the Ministry of Mines. A detailed study was carried out by IIT Madras by taking actual bore holes at site, and the samples collected were tested. IIT Madras Turn to page 8

Difficulty in closure of Advance Authorisation due to space constraints in the description column of the Shipping Bills

IT has come to the notice of this Directorate that in the process of closure of AA through the online system, certain issues are being faced by exporters due to inability of the system to capture complete description of the export items as per the export invoice. Item description with more than 120 characters may not completely reflected in Shipping Bills. In such cases, deficiencies are raised by RA for non-compliance of Para 4.42 (iii) of FTP 2023.

Therefore, it is directed that wherever such difficulties are encountered, RAs may corroborate the complete description of the export item and decide such cases on the basis of self-attested copies of GST system generated e-invoices.

In such cases, the aforesaid documents may be uploaded along with all the other prescribed documents for Redemption/EODC of Advance Authorisations.

This is issued with the approval of the DGFT.

MUMBAI Port Authority has approved an amendment to vessel related charges (lighterage) charges during the monsoon period.

The revised Clause 2.2(c)(i) of Chapter II - Vessel Related Charges of the Scale of Rates (SOR) can be found at the Mumbai Port Authority website www.mumbaiport. gov.in and Finance Corner.

It will come into effect after 30 days from the date of the Notification in the State Gazette (February 14).

certified that the sand was fit for reclamation purpose.

JNPA had applied to the Ministry of Mines for reservation and reclamation of the sand in October 2023. The Ministry reserved the said area for mining for VPPL on 21.12.2023 vide a Govt. Notification. And on Friday, February 28, 2025, the Ministry of Mines issued Mining Licence under Offshore Area Mineral (Development & Regulations) Act 2006 for a period of 10 years. The Letter of Intent (LoI) was handed over by the Minister of Mines & Coal, Mr G. Kishan Reddy, in the presence of Mr Devendra

Fadnavis, Chief Minister of Maharashtra, to CMD VPPL and Chairman JNPA, Mr Unmesh Sharad Wagh, IRS. The Secretary Mines, Govt. of India, Mr V. Kantha Rao, IAS, and the Minister of Mines, Govt. of Maharashtra, Mr Shambhuraj Desai, were also present.

The cost of extracting 200 million CuM sand from land is Rs 12,000 crore, which includes Rs 1,440 crore as royalty to the Government of India. But sand from the sea has saved Rs 6,000 crore compared to sand and murum from land sources. Apart from cost savings, mining from the sea has negligible environmental impact compared to mining on land, highlighted a release.
